## **Role Summary:**

This is a unique opportunity for an experienced coach to help shape the performance pathways for Australian Curling and contribute to future Olympic success.

The primary purpose of the Head Coach role is to facilitate the training and competition program of an elite Mixed Doubles Curling team leading up to the World Championships in 2024. The role includes the development and management of performance plans, day-to-day training, travel with the team for tour events during the season and team coach at World Championships.

#### In addition, the Head Coach will:

- Contribute to development of Coaching and Officiating pathways for Australian Curling, helping to set out the framework for identifying, recruiting, training and supporting the development of curling coaches and officials in Australia.
- Contribute to development of an Athlete Categorisation Framework for Australian Curling that identifies pathways and development opportunities from foundation to elite level.
- Where circumstances permit, assist with other coaching and athlete development programs run by the ACF.

# **Key Responsibilities:**

- In-person support of elite Mixed Doubles team while training and competing: develop, manage and
  deliver all aspects of team's program to meet established key performance indicators (KPIs) in their
  What It Takes To Win profile (WITTW) whilst liaising with key stakeholders to optimise player
  performance and well-being. Expected to be responsible for stakeholder relationships for elite
  team
- As time permits and in conjunction with stakeholders such as the ACF Executive Committee and Athlete Commission (AC) members, develop and implement an athlete categorisation framework with clear indicators and a performance trajectory to build depth in Australia (aligned with Australian Institute of Sport's National Categorisation Framework)
- Develop and implement a coaching and officiating framework in consultation with stakeholders
  (e.g. ACF Executive and AC) which includes establishing a database of expertise with a gap analysis
  and areas of need prioritisation assessment, creating a coaching and officiating roadmap that
  includes resources and professional development opportunities
